Evaluation Methods Used:

Conjuguemos was evaluated using Chrome v. 125.0.6422.142 on a macOS 14 laptop computer. Assistive technologies used in this evaluation included macOS VoiceOver (screen reader) as well as exclusive use of the keyboard to navigate and operate the site content and functionality.
